- 1 The above financial results were reviewed and recommended by the Audit Committee and approved by the Board of Directors at its Meetings held on August 5, 2015.
- 2 The company is in the business of power. Consultancy income has not been reported separately as the same being insignificant.
- 3 Services Charges of 568 lacs during the quarter (corresponding quarter ended June 30, 2014, 531 Lacs) have been recognized as income from sale and purchase of electricity through Energy Exchanges.
- 4 MU's sold include 540 MU's for the quarter (for the corresponding quarter ended June 30, 2014, 554 MU's) under "Energy Banking Arrangement".
- 5 Income from operation of the company includes sale of electricity, rebate on purchase of power and service charges. Purchases include purchase of electricity and rebate on sale of power.
- 6 In accordance with the accounting policy, the surcharge recoverable on late/ non-payment of dues by customers is recognized when no significant uncertainty as to measurability or collectability exist. Correspondingly surcharge liabilities on late/ non-payments to the suppliers, in view of the matching concept, is not being recognized in the accounts. The estimated liability in this regard, however is lower than the company's claims from its sundry debtors.
- 7 The company has recognized surcharge of ₹ 268 lacs during the quarter (for the corresponding quarter ended June 30, 2014, ₹ 49 lacs) from sundry debtors on amounts overdue on sale of power which has been included in "other operating income".
- 8 Other expenses include Corporate Social Responsibilities expenses (CSR) of ₹ 100 lacs (corresponding quarter ended June 30, 2014, ₹ 19 lacs) incurred during the quarter.
- **9** Figures of quarter March 31, 2015 are balancing figures between audited figures in respect of the full financial year and the published year to date figures up to the third quarter of the relevant financial year.
